



Adoption Contract

I, _____ (please print), hereby agree to adopt the animal(s) referenced below (hereafter "animal") from FOR ANIMALS INC and release and indemnify FOR ANIMALS INC and its officers, directors, trustees, employees, volunteers and agents from and against all claims for property damages and/or for personal injury to myself or others associated with this adoption or who have access to the animal. While under my care, the welfare of this animal will be my sole responsibility. I am not adopting this animal for another person, nor will this animal be used for breeding, medical or experimental research or any other purpose. I understand that in the event I give false information or do not follow the terms of this contract, FOR ANIMALS INC may reclaim this animal and begin legal proceedings against me at my expense and may assess damages up to the maximum permitted by law resulting from any false information or breach of the terms of this contract.

- If not already spayed/neutered, I will take the animal immediately to a veterinarian to be spayed/neutered. In the case of a kitten/puppy, I will spay/neuter the animal when it reaches the required age of maturity and notify FOR ANIMALS INC in writing. The cost of spay/neuter will be covered when a FOR ANIMALS INC approved veterinarian is used.
- I agree to pay the appropriate non-refundable adoption fee for the animal I am adopting: \$150 for a kitten or a cat, \$300 for a puppy or dog, \$75 for a rabbit.
- If not already provided, I will take the animal to a veterinarian for necessary inoculations and examination. (See attached for inoculations/tests already provided.)
- I agree to never declaw (surgically remove the claws of) a cat/kitten adopted from FOR ANIMALS INC and will consult FOR ANIMALS INC for alternatives. I accept this animal as a family member. If the animal ever becomes lost I will contact FOR ANIMALS INC immediately. I will search the area, post notices, visit all area shelters, and do everything humanly possible to find the animal.
- If in the future I cannot keep the animals for any reason, I will notify FOR ANIMALS INC immediately and work with FOR ANIMALS INC to find another suitable home. Approval of a suitable home proposed by either party not to be unreasonably withheld by the other party. If no mutually agreeable home is found within a month, I will return the animals to FOR ANIMALS INC.
- FOR ANIMALS INC will contact me for further verification of my new animal's welfare. I will cooperate by providing whatever information is required. I will allow a follow-up home visit, which can be virtual if I so choose, after the animal is in my home.
- FOR ANIMALS INC For Animals, Inc. may reclaim the animal for cause (i.e., the animal is being abused or neglected, or is being kept for a purpose other than companion animal) by providing notice to me.
- I do not hold FOR ANIMALS INC responsible for any omissions or errors in information provided to me.

I give FOR ANIMALS INC permission to use the adoption photo as well as photos/videos provided by me for promotional materials or online.
